NEVADA STATE APPRENTICESHIP COUNCIL SIMILAR PROGRAMS  
MEETING MINUTES – December 20, 2023

Nevada State Apprenticeship Council (NSAC) members present: Chairman Archie Walden, Vice-Chairman Jeremy Newman, Ryan Bellows, Madison Burnett, Mike Kennedy, Steve Ingersoll, Craig Statucki, Tom Burns.

Also present: Brett Harris, Toni Giddens, Patricia Garcia.

**1. Call to Order.**

Chairman Walden called the meeting to order at 8:04 AM

**2. Roll Call and Quorum.**

Per direction from Chairman Walden, State Apprenticeship Director Giddens took a roll call and confirmed the presence of a quorum.

**3. Verification of Public Posting.**

Director Giddens affirmed pursuant to Nevada Revised Statutes (NRS) Section 241.020, the Nevada Open Meeting Law, that the agenda and notice for the meeting were properly posted.

**4. Public Comment.**

Chairman Walden called for public comment. Hearing no comment, Chairman Walden closed the initial public comment period.

**5. New Program Standards and Apprenticeship Agreement.**

Chair Walden called for a representative of Heat & Frost & Allied Workers Local #69 to present their proposed program. Robert Cochran, Coordinator was present to represent the program. Mr. Cochran stated that they are working to get an apprenticeship going for their local's territory covering Northeastern Nevada. Mr. Cochran provided information on their established program in Utah. Council Member Burnett asked if this was a 4 year program covering the 8,000 hours required, this was verified by Mr. Cochran. Council Member Burnett also asked about work process and related instruction as this was not spelled out in the Appendix A. Mr. Cochran stated that he would get that information added and returned to the State Apprenticeship Director. Hearing no further questions, Chair Walden presented

a motion to approve the standards subject to the changes requested. Council Member Ingersoll seconded the motion. Motion carried.

**6. Public Comment.**

Chairman Walden called for public comment. Hearing none he closed public comment.

**7. Adjournment.**

Chairman Walden adjourned the meeting of the Nevada State Apprenticeship Council at 08:14 AM.
